

**Gasworks Plaza / Your Table's Ready
Terms and Conditions**

1. These terms and conditions apply to entrants to the 'Your Table's Ready' Centre Promotion ("Promotion"). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The "Promoter" is Dexus Shopping Centre Pty Ltd ABN 13001595955 of Gasworks Plaza, 76 Skyring Tce, Newstead, Queensland 4006.
3. This promotion will be conducted at Gasworks Plaza 76 Skyring Tce, Newstead, Queensland 4006.

ELIGIBILITY

4. This Promotion is only open to individuals who are aged 18 years or over, and make a purchase at Gasworks Plaza between the Promotion period.
5. The following individuals are ineligible to enter the Promotion:
 - a. employees, directors, officers and management of the Promoter, any related bodies corporate of the Promoter, or any of the tenants or retailers in the participating Centre/s or any of the Promoter's agencies that are associated with the Promotion;
 - b. the spouse, de facto spouse, parent, child or sibling of an individual listed in paragraph a.; and
 - c. any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

PROMOTION PERIOD

6. This Promotion commences at 9:00am on Monday 21 September 2026 and ends at 11:59pm AEST on Sunday 18 October 2026. ("Promotion Period").

HOW TO ENTER

7. To enter this Promotion, eligible individuals must, during the Promotion Period:
 - a. Spend a minimum of \$50 at any participating Gasworks Plaza dining retailer during the campaign period (refer to Annexure 1 for Participating Retailers) and collect your itemised purchase receipt.
 - b. Scan the QR code at any participating dining retailer or in-centre at Gasworks Plaza. Alternatively, entrants can complete the online form available on the Gasworks Plaza website.
 - c. Fill out and submit the online entry form, including uploading an image of the Qualifying Purchase receipt and all other requested information. Each qualifying receipt is equal to one entry into the prize draw.

- d. The same receipt cannot be submitted multiple times. Receipts can only be used once. Duplicate receipts will be rejected in the portal.
 - e. Entrants will receive a notification confirming whether their receipt has been successfully validated or if the receipt does not meet the eligibility criteria. The entrant will receive a notification if the receipt has been rejected.
- 8. Uploaded receipts must clearly show the Gasworks Plaza retailer name, Tax Invoice number, transaction date, purchase amount.
- 9. The Promoter is not responsible if your mobile device/ desktop is not sufficiently capable for the purpose of submitting an entry, including having the requisite photograph capability.
- 10. Incomplete, illegible, altered, fraudulent or duplicate receipts will be deemed invalid.
- 11. Entries must not appear to promote any goods or services other than those of the Centre or the Centre's retailers participating in this Promotion.
- 12. Receipts from the purchase of tobacco, lottery tickets or gift cards are not accepted as part of this Promotion.

PROOF OF PURCHASE

- 13. You must keep your original itemised purchase receipt(s) as proof of purchase for all entries. If you don't produce the above proof of purchase for all entries when asked, the Promoter may disqualify your entry, and you will lose any right to a prize.
- 14. Proof of purchase must be identical to that provided by you with your entry.
- 15. If, in the Promoter's opinion based on the available information, you have shared any proof of purchase with another person, your entries will be invalid, and you will lose any right to a prize.
- 16. Receipts must not be tampered with, manipulated, altered or generated in any way. If, the Promoter reasonably suspects, based on the information available, that a receipt may have been tampered with, altered, manipulated or generated, you will be asked for further information to allow the Promoter to validate your receipt. If the information you provide does not establish the validity of your receipt (to the Promoter's reasonable satisfaction) or you fail to provide such information in the timeframe reasonably requested, the Promoter may invalidate your entry/ies or cancel your prize.

LIMITS ON ENTRY

- 17. You can enter multiple times, provided you only enter once per Qualifying Purchase and per original itemised receipt. Each entry must be submitted separately in accordance with these Terms and Conditions.
- 18. To avoid doubt, there is a limit of one entry per Qualifying Purchase receipt. For example, if you spend \$100 in a single Qualifying Purchase transaction, that receipt can only be used to enter once.

PRIZE DETERMINATION

19. The draw will take place at Gasworks Plaza, 76 Skyring Tce, Newstead, Queensland 4006 at the draw times set out below. The Promoter may draw reserve entries and record them in order in case of an invalid entry/entrant or a prize is unclaimed.

WEEKLY PRIZE

23. Once verified, each winner will receive a \$250 Gasworks Plaza Dining e-Gift Card sent to the winner's email address.
24. Weekly prize gift cards may only be redeemed at participating retailers.
25. Weekly prize gift cards are valid for three (3) months from the date of issue, unless otherwise stated on the gift card.

- 26. Weekly prizes are not transferable, exchangeable or redeemable for cash.

MAJOR PRIZE

WINNER NOTIFICATION

- 35. The provisional winner will be notified via email within 14 days of determination. A provisional winner will only be deemed a winner once their identity is verified by the Promoter. A winner of a prize may have their name published on Gasworks Plaza Facebook or Instagram pages from 21/09/2026 for a period of 28 days.
- 36. Weekly prize winners and the Major Prize winner will be sent digital gift cards via email once the winner's details have been verified with the eligibility criteria.
- 37. A winner's right to receive a prize is subject to verification of identity and compliance with the eligibility criteria of this Promotion.
- 38. The Promoter or the Partner will not be responsible for any prize that is lost, stolen, delayed or damaged after the winner has collected the prize.

41. The Gasworks Plaza Dining e-Gift Card can be redeemed at the following Gasworks Plaza retailers: Bakery by The Standard Market Company, Italian Street Kitchen, Mecca Bah, Milky Lane, Nonda, Ping Pong, Quench, Neighbour by Range, Fishbowl, HG Newstead, Reef Seafood & Sushi, Smokey Moo, Sunnyside Sliced, Wara Sushi, Yo-Chi and Yolk.

UNCLAIMED PRIZES

42. **Weekly Prizes claim date:** 28 days from the date of the winner notification email.
43. Any weekly prizes that remain unclaimed by the weekly prize claim date above will be forfeited and the Promoter may dispose of such prizes as it sees fit.
44. **Major prize claim date:** By 9pm AEST Monday 16 November 2026.
45. If the major prize has been won but remains unclaimed by the major prize claim date above or if, after making all reasonable attempts, the Promoter can't contact the winner, it will be entered into the unclaimed prize draw or re-awarded by the Promoter to a Major Prize Reserve Entrant. GENERAL

48. If relevant, incomplete, indecipherable or illegible entries will be deemed invalid.

49. If there is a dispute as to the identity of the entrant, the Promoter reserves the right to determine the identity of the entrant.

50. Prizes are subject to the standard terms and conditions of individual prize and service providers. If for any reason a winner does not take a prize or an element of a prize at the time stipulated, then the prize or that element of the prize will be forfeited and will not be redeemable for cash. Any failure by you or (if applicable) your companion/s to comply with the conditions imposed by the prize supplier(s) may result in the prize being cancelled or withdrawn without liability for the Promoter or the prize supplier(s).

51. For event based/travel prizes, you and (if applicable) your companion/s accept that some aspects of the prize may be inherently risky and that the prize may involve dangerous activities.

52. 53. You/your companion/s must, if required by the Promoter, sign disclaimer and release forms provided by the Promoter in favour of the Promoter and other parties before taking the prize. If you or any companion/s do not sign, your entry will be deemed invalid, and you will lose any entitlement to a prize.

54. If companion/s can take the prize with you, you are responsible for your companion/s and the Promoter may disqualify all entries from, and prohibit further participation in this competition by, you or any or all of your companion/s if they breach these conditions, whether or not legally bound by them.

55. If you (or your companion/s, if applicable), in the opinion of the Promoter (and/or a medical professional, as relevant to the circumstances), are intoxicated, under the influence of alcohol or any other drug, behave aggressively or offensively, or behave in a manner which may diminish the good name or reputation of the Promoter or any of its related entities or the agencies or companies associated with this competition, is contrary to law or is otherwise inappropriate, the Promoter may cancel the prize or restrict you (and your companion/s) from participating in any elements of the prize, at its discretion.
56. The Promoter is not responsible for any dispute between you and any person with whom you choose to, or choose not to, share a prize.
57. 59. Entrants consent to the Promoter using the entrant's name, likeness, image and/or voice in the event they are a winner (including photograph, film and/or recording of the same) in any media without remuneration for the purpose of promoting this Promotion (including any outcome), and promoting any products manufactured, distributed and/or supplied by the Promoter or the Promoter's retailer(s).
60. The Promoter reserves the right, at any time, to verify the validity of entries (including contacting participating retailers) and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
61. If this Promotion is interfered with or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right to the fullest extent permitted by law to (a) disqualify an entrant engaging in unauthorised intervention or fraud; or (b) subject to any written directions from a regulatory authority to modify, suspend, terminate or cancel the Promotion, as appropriate.
62. If any dispute arises concerning the conduct of this promotion, the Promoter will take reasonable steps to consider your point of view, taking into account any facts or evidence you put forward, and to respond to it fairly within a reasonable time. However, the Promoter's decision is final, and no correspondence will be entered into.
63. Any cost associated with accessing the promotional website is the entrant's responsibility and is dependent on the internet service provider used. The use of any automated entry software or any other mechanical or electronic means that allows an entrant to automatically enter repeatedly is prohibited and will render all entries submitted by that entrant invalid.

64. Your entry must be received during the Promotion Period and will be deemed to be received only when received by the Promoter. Where relevant, entry forms/scratch cards from any other competition cannot be used for this competition, and are void if copied, forged, stolen or interfered with. If online or SMS entry is available, you will receive a return message confirming your entry. You are responsible for your own costs associated with entering. If you enter using multiple phone numbers/email addresses/addresses/aliases, you may be disqualified.
65. The Promoter is not responsible for any tax implications arising from you winning a prize. You should seek independent financial advice. If for GST purposes this Promotion results in any supply being made for non-monetary consideration, you must follow the Australian Taxation Office's stated view that where the parties are at arm's length, goods and services exchanged are of equal GST inclusive market values.
66. Entrants agree that they are fully responsible for any materials they submit in relation to this Promotion including but not limited to comments, recordings and images ("Content"). The Promoter shall not be liable in any way for such Content to the fullest extent permitted by law. The Promoter may remove or decline to publish any Content without notice for any reason whatsoever. Entrants warrant and agree that:
- they will not submit any Content that is unlawful or fraudulent, or that the Promoter may deem in breach of any intellectual property, privacy, publicity or other rights, defamatory, obscene, derogatory, pornographic, sexually inappropriate, violent, abusive, harassing, threatening, objectionable with respect to race, religion, origin or gender, not suitable for children aged under 15, or otherwise unsuitable for publication;
 - their Content shall not contain viruses or cause injury or harm to any person or entity;
 - the Content is the original work of the entrant that does not infringe the rights of any third party;
 - they consent to any use of the Content which may otherwise infringe the Content creator's/creators' moral rights pursuant to the [*Australian Copyright Act 1968* (Cth)] and warrant that they have the full authority to grant these rights; and
 - they will comply with all applicable laws and regulations, including without limitation, those governing copyright, content, defamation, privacy, publicity and the access or use of others' computer or communication systems.

Without limiting any other terms herein, the entrant agrees to indemnify the Promoter for any breach of the above terms.

67. The Promoter (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including without limitation:
- any technical difficulties or equipment malfunction;
 - any theft, unauthorised access or third party interference;
 - any entry or correspondence that is late, lost, altered, damaged or misdirected due to any reason beyond the reasonable control of the Promoter;
 - any variation in the prize value to that stated in these Terms and Conditions;
 - any tax liability incurred by an entrant or winner; or
 - use of the prize,

except for any liability which under statute, including under the Non-Excludable Guarantees, cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).

68. This Promotion is in no way sponsored, endorsed or administered by, or associated with any social media platform, including Instagram or Facebook. You provide your information to the Promoter and not to any social media platform. You completely release any relevant social media platforms from any and all liability.
69. In order to conduct this Promotion, the Promoter needs to collect personal information about each entrant and may for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, if required, to Australian regulatory authorities. Participation in the Promotion is conditional on providing this information.
70. By entering, you consent to the Promoter using this information for promotional, marketing, publicity and research purposes, including telephoning the entrant or sending email or SMS messages provided that where required by the *Spam Act 2003* (Cth), the Promoter includes a functional unsubscribe facility in each direct marketing communication it sends you that you may use to opt-out of any further such communications and provided that the functional unsubscribe facility complies with the *Spam Regulations 2021* (Cth). You also consent to receive email or SMS messages from the Promoter without any functional unsubscribe facility if they relate primarily to the conduct of this competition. If you have marked the “opt-in” box on the entry form relating to a third party collecting your personal information, you consent to the storage of your personal information on the specified third party's database/s and the specified third party may use this information for future promotional and marketing purposes regarding their products and services including contacting you via electronic messaging provided that where required by the *Spam Act 2003* (Cth), the third party includes a functional unsubscribe facility in each direct marketing communication it sends you that you may use to opt-out of any further such communications and provided that the functional unsubscribe facility complies with the *Spam Regulations 2021* (Cth). You should contact the relevant third party/ies for their privacy policy/ies.
72. The Dexu Group Privacy Policy also contains information about how entrants may access, update or correct their personal information and how Australian entrants may complain about a breach of the Australian Privacy Principles and how those complaints will be dealt with.
